#### **LOCATE INTERESTED CANDIDATES**

The recommendation process is made available to candidates in all local races across Wright County. The process is initiated once a candidate declares their interest to the Wright County BPOU Executive Comittee. Once a candidate requests recommended status, the BPOU will attempt to contact all candidates in that race to offer the oppunity.

#### **BACKGROUND SEARCH**

Once a candidate has requested Remmendation, a questionnaire will be provided. The BPOU Recommendation Committee will also perform an independent background investigation.

#### **INTERVIEW**

After completion of the background search process, the candidate will be required to attend an interview with the Recommendation Comittee. The committee will be made up of the executive board along with each candidate's regional chair. This interview will be scored by each member of the committee on a standardized form. This interview will be available to all members of the BPOU Full Comittee.

#### **VOTE**

The Recommendation Comittee will meet after the interview process to discuss each candidate and whether a recommendation is appropriate. In each race, only the number of seats open on the ballot may earn the recommended status.
